Is there a tax credit for roofs? No, not under the law covering returns for the 2023 tax year. If you replaced or added a new roof to your home between 2017 and 2022 and did not yet claim it, you could qualify for an energy-efficient home improvement tax credit for as much as 10% of the cost (not including installation costs), up to \$500.

This is a tax credit for making certain energy-efficiency improvements to homes, such as installing energy-efficient exterior windows, doors, and skylights. As long as the upgrades meet Energy Star standards, you will qualify to claim the energy tax credit. This credit is worth 30% of the cost and a maximum of,

The Residential Clean Energy (RCE) Credit is a renewable energy tax credit extended and expanded by the 2022 Inflation Reduction Act. The credit is worth 30% of certain qualified expenses for residential clean energy property.

Amount: This tax credit is valued at 30% of the cost paid by the consumer, up to \$600. May be eligible for a Home Efficiency Rebate, which provides up to \$8,000 off projects that significantly reduce household energy use..
