"Patriarchy" as fatherly authority. The word "patriarchy", as derived from the Greek patriarchisi (father who rules over a family) has immediate connotations of power, family-relations and social hierarchy. What it does not contain, in these etymological origins, is the subtext of oppressive domination that in feminist usage of the term seems obvious.

The main difference between patriarchy and paternalism is that patriarchy is a system of society where men hold positions of power, mainly excluding women from it, while paternalism is a system under which the people in authority restrict the freedom and responsibilities of those subordinate to them in their supposed interest..
