Functionalism: - Industrialization helps society progress toward longer life spans and better quality of life
Conflict Theory: - Industrialization continues to concentrate wealth and power in the hands of those who already have it, both within countries and between countries
Symbolic Interactionism: - Industrialization changes the use of language through means of technology.

This includes creating local and context-specific curricula for teaching language and cultural beliefs and practices, creating opportunities to connect youth with Elders and other knowledge keepers, developing or adapting culture-forward interventions, and engaging in national efforts that draw on Indigenous ecologies to make sociopolitical ...

Despite its limited success, the American System was important to the industrialization of the United States, because it laid the groundwork for later transportation and infrastructure projects that would enable economic growth and expansion. Although the American System was first implemented in 185, it did not have a formal name until 1824.

The American System included financial support for roads, canals, bridges. These improvements to the nation's infrastructure would facilitate trade and increase accessibility to markets. Control over language and information is referred to as power/knowledge. Foucault asserts that power is inherently tied to control over and access to information and vice versa. Knowledge is always related to systems of power. James Baldwin (1979) similarly refers to language as a political instrument.

Mercantilism is a common phenomenon in history as it is today. Tudor England and postwar Japan were successful examples. Under this common umbrella, practical strategies and policies are highly diversified, but two features are common: the search for power and wealth; and actively accumulating foreign exchange reserves through industry and commerce.

The American System was proposed. Clay first used the term "American System" in a speech he gave in 1824. It was a federal policy based on a market economy. Sections of the country would produce specific commodities which they would sell to other regions. (See his 1830 speech: "A System of Real Reciprocity.") The policy had three main components:

The wealth of the middle class has also been declining in recent decades. Its share of the wealth fell from 32 percent in 1983 to 16 percent in 2016 (Horowitz, Igielnik, & Kochhar 2020). People with wealth often receive the most and best schooling, access better health care, and consume the most goods and services.
