



# Basin electric power cooperative transmission system

Recent years have been tough for other electric utilities, but Basin Electric's ability to finance needed capital requirements at a reasonable cost is a key factor in sustaining our credit quality and providing a cost-based power supply to our members. The Basin Electric board of directors has authorized a Class A rate increase of \$4 per megawatt-hour (MWh), or approximately 6.5%, beginning January 1, 2025. Basin Electric's financial forecast indicated the need for an approximate \$5.20 per MWh rate increase, however after feedback from members, the board elected to use a portion of the Rate Stability Fund to ...

A lower cost of borrowing money translates to a lower total cost to build generation and transmission, meaning more affordable electricity for the cooperative family.
