Oregon's renewable fuel standard requires nearly all gasoline sold to be a 10 percent ethanol blend. A higher blend of ethanol - known as E85 - is also available in Oregon. This fuel must be used in flexible fuel vehicles, which can run any combination of gasoline and ethanol blends.

The bill provides two definitions for "renewable hydrogen" and "green electrolytic hydrogen," and directs the Oregon Department of Energy to apply for federal funding that would support ...
