(2) A deed restriction, covenant, declaration, or similar binding agreement may not prohibit or have the effect of prohibiting solar collectors, clotheslines, or other energy devices based on renewable resources from being installed on buildings erected on the lots or parcels covered by the deed restriction, covenant, declaration, or binding agreement.

If you are living in a Homeowners Association the Board or the Architectural Review Committee generally cannot prohibit the installation of solar panels (or "solar collectors"). A Florida law, F.S. 163.04, provides that any "deed restriction or declaration" or even any "similar binding agreement" may not prohibit -- or have the effect of prohibiting --

Florida Solar Access Law. Florida Statute 163.04 forbids homeowners in Florida from installing solar panels on their property. These Florida HOA restrictions are for solar devices that fall under the state's Solar Access Laws: The Florida solar panels must be oriented south, or 45 degrees east or west from true south.

No. Florida Statute 163.04 states that no binding agreement (including HOA agreements) can prohibit a property owner from installing solar panels or any other energy devices based on renewable resources.

HOAs can't legally prohibit anyone from acquiring solar panels (or any other ...

Homeowners associations in Florida. Florida Statute 163.04 forbids any binding agreement (between HOAs, condo associations or otherwise) to prohibit a property owner from installing solar. An HOA may restrict where you place your solar panels, but not if the system's performance suffers as a result.
