panels within a homeowners' association is addressed in 64.38.055 of the Revised Code of Washington (RCW) which is the compilation of all permanent laws now in force. Read rules referring to solar panels in the context of HOAs.

While your HOA can't prohibit solar panel installation, it does have a voice in this matter. A review board or committee can determine the specific roof location on which the panels are to be installed as long as it is "within an orientation to the south or within 45°; east or west of due south if such determination does not impair the ...

Each state has its own set of laws regarding solar access, which can influence how HOAs govern solar panel installations. For instance, some states have "solar easement provisions" that limit the ability of HOAs to restrict solar installations outright. Federal laws also play a role, particularly through policies that encourage renewable energy.
