The news was greeted with a mixture of elation and relief by the 410 plus staff working at the Dublin Road plant. It lifted the business out of liquidation after parent company, CG Power Systems Belgium NV, went bankrupt back in February.

The liquidation decision did not impact the Belgium entities only. CG Power Systems also own the transformer factories in CG Ireland and CG Indonesia. The CG transformer factories in Hungary and India are not impacted by the liquidation. In 2016, it was widely reported that the CG interests had been up for sale.
