The \$37 million project, which was financed and constructed by Lightsource BP, is located approximately two miles southwest of Johnson City in Stanton County, Kansas.

The JCSP is currently the largest operating commercial solar facility in Kansas. It will be matched in size in January 2025 with the expected commercial operation of the Russell solar facility.

The Johnson Corner solar project, which was the largest solar farm in Kansas when it came online in 2020, consists of 75,000 solar panels installed across 144 acres of land in Stanton County, 2 miles from Johnson City. Commercial operation commenced in April 2020.
