The Arizona Legislature passed ARS-33-439 in 1979 in order to protect individual homeowners private property rights to use solar energy. A.R.S. § 33-1816 (33-1816 - Solar energy devices; reasonable restrictions; fees and costs) A.R.S. §33-439 (33-439 - Restrictions on installation or use of solar energy devices invalid; exception)

The Arizona HOA solar panel law, outlined in Arizona Revised Statute 33-1816, states that your HOA may establish reasonable guidelines for the placement of your solar panels but cannot outlaw them. These guidelines must not obstruct installation, impair device functionality, limit how the device can be used, or make it less effective or ...

Colorado law (C.R.S. 38-30-168) addresses the authority of HOAs to regulate the installation and use of "solar energy devices" which are defined as ". . . a solar collector or other device or a structural design feature of a structure which provides for the collection of sunlight and which comprises part of a system for the conversion of ...
