



# Do solar panels increase property taxes california

California's solar property tax exclusion was set to expire earlier this month. If it were to be allowed to expire entirely, California would have a utility-scale solar tax burden 400%-700% greater than neighboring states, according to state Sen. Robert Hertzberg, a Democrat.

Generally, when something of value is physically added to real property, the addition is assessed at current market value and this value is added to the existing base year value of the real property. When an active solar energy system is installed, it is not assessed, meaning that the existing assessment will not increase.

Property tax exemptions help negate annual, longer-term costs with solar. When a state or locality has a property tax exemption for a solar system in place, your tax bill doesn't include the added property value from your solar panels. Property tax exemptions may be implemented on a state or local level.

California extended a property tax exemption for solar projects placed in service by the end of 2026. The projects remain exempted until there is a change in control. The exemption had been scheduled to expire at the end of 2024. It has been extended multiple times since the 1980s.

As of January 1, 2020, California requires solar-energy systems on all new residential homes. Solar markets vary by state, but they can also vary from city to city within each state. ... Some active solar energy properties may be eligible for exclusion from reassessment. Effective September 18, 2022, the sunset date for the active solar energy system new construction exclusion was extended through 2025-26 fiscal year. The statute is now scheduled to sunset on January 1, 2027.
