The EPCOR Water - Sun City District provides water for about 38,016 residents living in the area of Sun City, Arizona. Established in 1996, the EPCOR Water - Sun City currently obtains its supply from s groundwater source, wells that pump water from the West Salt River Valley (WSRV) Sub-Basin.

EPCOR is a private water utility that owns and operates the potable water system in the community. While there are many other numbers to look at, the bottom line is that during 2020 the Town of Fountain Hills used 6,265 acre-feet of water, which according to EPCOR is roughly 28 percent of the total available supply of 21,567 acre-feet.

On January 26, 2022, the Arizona Corporation Commission (ACC) voted to approve EPCOR's 2020 water rate case. The ACC's decision combined six districts together. Agua Fria, Anthem, Chaparral, Havasu, Tubac, and Willow Valley are now grouped as EPCOR's Sonoran water district. New rates initially went into effect February 1, 2022.
