Legislators in the state of Maryland have voted to approve HB 910, establishing a target to install energy storage to support the proliferation of renewable energy statewide. The target sets a goal of 750 MW by year's end 2027, 1.5 GW through 2030, and 3 GW through 2033.

Solar Tax Credit: Most solar energy installations are eligible for the Residential Clean Energy Credit, previously called the Solar Investment Tax Credit (ITC). Eligible homeowners can deduct up to 30% of their solar power system"s costs from their total tax liability for the year of ...

Maryland Battery Backup Incentive. Maryland also offers a tax credit of 30% of the total installed costs of the energy storage system up to \$5,000 for a residential property; or, up to \$75,000 for a commercial property. Maryland approved the tax credit through 2022, however, there is a set amount available on a first-come first-served basis.

Two other Exelon-owned energy suppliers in Maryland, Pepco and Delmarva Power, are also building BESS pilot projects under the Maryland Energy Storage Pilot Project Act of 2019, with the state figuring out the best way forward to hit its target of deploying 3,000MW of energy storage by 2033.
