Florida Law on Solar Installations. Florida law is generally supportive of solar installations. In 2008, the state passed the Florida Solar Rights Act, which prohibits HOAs and local governments from prohibiting the installation of solar collectors, equipment, or systems on residential properties.

A Florida law, F.S. 163.04, provides that any "deed restriction or declaration" or even any "similar binding agreement" may not prohibit - or have the effect of prohibiting - solar collectors, clotheslines or any other energy devices based on renewable resources, from being installed on buildings or lots within the association.

The solar company allegedly misled consumers about the solar panel system installation process and relevant incentives or credits. Vision Solar also allegedly failed to successfully complete the permit requirements in setting up consumers' solar grids, resulting in unexpected fines or liens for the customers.

M2301.2.2.1 Roof-mounted collectors.. The roof shall be constructed to support the loads imposed by roof-mounted solar collectors. Roof-mounted solar collectors that serve as a roof covering shall conform to the requirements for roof coverings in Chapter 9 [the High-Velocity Hurricane Zone (HVHZ) shall comply with Chapter 44] of this code. Where mounted on or above the roof ...

(1) It is the intent of the Legislature to encourage renewable solar electrical generation throughout this state. It is essential that solar facilities and associated electric infrastructure be constructed and maintained in various locations throughout this state in order to ensure the availability of renewable energy production, which is critical to this state's energy and economic future.

(1) Notwithstanding any provision of this chapter or other provision of general or special law, the adoption of an ordinance by a governing body, as those terms are defined in this chapter, which prohibits or has the effect of prohibiting the installation of solar collectors, clotheslines, or other energy devices based on renewable resources is expressly prohibited.

The inspection must be completed before the system is connected to the grid, and any necessary repairs or adjustments must be made before the system can be turned on. Another important aspect of Florida's solar laws is the process of obtaining a permit to install a solar panel system.

This requirement is in place to ensure that excess solar power is not wasted and can be used by others. In addition, Florida law also requires that all solar panel systems be inspected by a certified solar contractor. This inspection is designed to ensure that the system is installed correctly and is safe for use.

In 2020, Florida electric utilities reported 90,552 customer-owned rooftop solar connections, nearly one-third more than in 2019. Under the bill, rooftop solar owners will be given a credit at current retail rates for the energy they generate and sell back to the grid for the utility to use only through 2024.

Florida Solar Panel lawsuits are getting more and more common. "Solar Panels are free!" During a Solar Panel lawsuit, I'm finding that generally there is no up-front cost for the homeowner for the installation of the solar panels; however, there is generally a surprise bill that the homeowner receives 2 to 3 months later.

Off-grid electricity systems, including solar and wind power, are legal in Florida. There are no laws preventing you from disconnecting from the power company and creating your own "microgrid." In almost all cases, you must get a permit for your system.

At the state level, there are 2 incentives for solar in Florida. Solar is exempt from sales tax, which greatly reduces the final cost. Solar is exempt from property tax, meaning that ...
