No, FPL does not offer rebates or other solar incentives. However, FPL is invested in supporting Florida solar. In 2016, FPL built three 74.5 MW solar arrays, each of which have the capacity to generate power for about 15,000 homes.

FPL expects the funding cap for new solar PV rebates to be reached quickly due to growing interest in distributed solar generation. Interested customers should begin exploring options as soon as possible to ensure that they have time to identify a contractor and gather the required information before the application period opens on June 21.

From 2011 through 2013, these programs cost FPL customers nearly \$30 million, including \$16.5 million to provide rebate subsidies for about 900 customers' individual small-scale solar-panel installations - the least economical form of solar photovoltaic (PV) power.

"By unanimously approving FPL SolarTogether - the largest shared solar program in the country - the FPSC has, once again, reminded the world that Florida is committed to leading by example when it comes to adapting to changing times and meeting customers' needs while taking a long-term view to keep costs down," said Silagy.
