Illinois incentives and rebates. Solar incentives and rebates can cut the cost of installing solar in Illinois by thousands of dollars. The most significant incentive is the 30% federal solar tax credit, available to any taxpayer in the country when they purchase solar panels or battery storage.

In Illinois, the Illinois Shines and Illinois Solar for All Programs provide incentives for the installation of new solar projects for residential and commercial customers through contracts for the sale of RECs to Illinois utilities.

Having backup storage of solar energy is effective in reducing electricity bills during the months when heating is working overtime. NEW! Smart Inverter Rebate. In Illinois, homeowners served by investor-owned utilities like Ameren Illinois and ComEd may be eligible for a Smart Inverter Rebate when they go solar. This incentive provides \$300 per kilowatt (kW) of installed solar power. For example, a typical 12kW solar system could save an Illinois homeowner \$3,600.

Those who already have a solar energy system can register with Illinois Shines and receive 15 years of payments in return for solar renewable energy credits (called SRECs or RECs). You'll receive credits for each megawatt (MW) of electricity produced over the payback period.

In addition to solar incentives, Illinois also offers some great battery incentive programs to bring down the price of energy storage. Solar carve-outs require a certain percentage of a state's renewable energy to come from solar by a certain deadline. The solar carve-out in Illinois is 1.5% by 2025.
