Some active solar energy properties may be eligible for exclusion from reassessment. Effective September 18, 2022, the sunset date for the active solar energy system new construction exclusion was extended through 2025-26 fiscal year. The statute is now scheduled to sunset on January 1, 2027.

Some of the solar systems that may qualify for the exclusion may include water heating, space condition, or production of electricity devices. This only applies if the owner-builder did not already receive an exclusion for the same active solar energy system. It also only applies if the initial purchaser purchased the new building prior to that building becoming subject to reassessment to the owner-builder.

R & T Code 73, Assembly Bill 1451 (Ch. 538, Stats. 2008). The property tax incentive for the installation of an active solar energy system is in the form of a new construction exclusion. Therefore, the installation of a qualifying solar energy system will not result in either an increase or a decrease in the assessment of the existing property.

The form is called the Initial Purchaser Claim for Solar Energy System New Construction Exclusion and is available from the assessor of the county where the property is located. After the assessor receives this form, the new base year value of the building may be reduced by the value of the active solar energy system, less any rebates or tax ...

Solar Energy Systems New Construction Exclusion. On December 6, 2012, the Guidelines for Active Solar Energy Systems New Construction Exclusion (Guidelines), was distributed in Letter to Assessors 2012/053. In September 2018, Board staff initiated a project to address issues that have emerged since the release of the Guidelines.

The initial purchaser must file a claim with the Assessor and provide any documents necessary to identify the value attributable to the active solar energy system included in the purchase price ...

The solar system exclusion applies retroactively to all eligible projects completed on or after January 1, 2008. Approximately \$1.5 billion in value of new active solar systems were installed in California between 2008 and 2010 and may be eligible for the exclusion.
