In addition to a 100% property tax exemption for residential solar panels, Florida law also exempts solar from its sales and use tax. According to the Florida Department of Revenue, the exemption applies to equipment and any component currently certified by Florida Solar Energy Center as a qualifying solar energy component. Community solar is limited in Florida. To have community solar, your utility must agree to voluntarily participate in community solar, or be forced to allow it by state-level legislation. In Florida, utilities offer "green/solar subscription" programs that are not true community solar.

Utility Bill Costs and Escalation Rates. The average retail cost of electricity in the state of Florida is slightly below the national average. According to the U.S. Energy Information Administration (EIA), as of August 2022, the average retail price of electricity in Florida is 12.8 cents per kilowatt-hour (kWh), which is below the national average of 13.6 ¢/kWh.

Florida law supports the idea that in the event of a power outage, ALL power needs to go out, including your solar system. If your solar system continued to feed the power grid with energy through net metering while the power was out, it could put utility workers at risk as they work to restore power to the grid.
