Finally, you will also probably have to pay a dangerous goods surcharge in order to actually send the package. Other Essential Considerations

Regulations vary depending on the kind of lithium batteries you are shipping (lithium ion or lithium metal), the maximum allowable amount of batteries, and whether you are shipping via ground or air transport. Also, regulations differ based on whether you are shipping the batteries by themselves or batteries pre-installed in equipment.

The lithium battery mark must be printed in color. Cut out the shipping label, packing slip and the lithium battery mark. Include the packing slip in your shipping package. Place the shipping label in the UPS shipping pouch. If you do not have a pouch, affix the label to your package using clear plastic shipping tape over the entire label.

The lithium battery mark is required as specified in the DGR. The border of the mark must have red diagonal hatchings with a minimum width of 5mm. The symbol (group of batteries, one damaged and emitting flame, above the UN number for lithium ion or lithium metal batteries or cells) must be black on white or a suitable contrasting background ...

Lithium metal batteries will use labels with one of the following UN numbers: UN3090 UN3091; If you're shipping lithium metal batteries as a standalone (no other items in the package), use a battery label with UN3090. If you're shipping lithium metal batteries contained in or packed with equipment, use a battery label with UN3091.

For shipping, all types of lithium batteries are classified as dangerous goods -- with special regulations for packing, labelling, documentation and handling. FedEx adheres to IATA regulations for shipping lithium batteries by air and ADR regulations for shipping lithium batteries by road in Europe.

Yes. In Canada, the shipping and importing of lithium batteries is subject to the Transportation of Dangerous Goods Act, 1992 (TDG Act) and its regulations. They are considered dangerous goods much like gasoline, propane and sulfuric acid. ... The appropriate lithium battery mark in accordance with Section 4.24 of the TDG Regulations. Until ...

Effective July 1, 2015, all existing customers and new customers who wish to ship lithium metal batteries without equipment (UN3090) via UPS 174; Air services must obtain pre-approval from UPS Airlines. This requirement is to ensure that proper training has occurred and that all applicable safety regulations are properly followed for such shipments.
