These solar PV modules will have to use solar PV cells from amongst the models and manufacturers enlisted in ALMM List-II for solar PV cells. Furthermore, solar PV modules already listed in ALMM list-I, with enlistment validity beyond March 31, 2026, will also be required to use solar PV cells from ALMM list-II starting April 1, 2026.

Under the scheme, it was proposed to set up at least 25 Solar Parks and Ultra Mega Solar Power Projects targeting 20,000 MW of solar power installed capacity within a span of 5 years starting from 2014-15. The capacity of the Scheme was enhanced from 20,000 MW to 40,000 MW on 21-03-2017. These parks are proposed to be set up by 2025-26.
