Government land will be allotted to Solar Park /Solar Power Project as per the provisions of Rajasthan Land Revenue (Allotment of land for setting up of Power Plant based on Renewable Energy Sources) Rules, 2007, as amended from time to time. Solar Power Park Developer shall be allowed to sub-lease the allotted land as per the aforesaid rules.

Landowners receive rental payments monthly from the solar developer based on per-acre use. For most solar land leases, rent rates increase by 1.5% to 2.5% annually. Solar land leases begin with either the solar developer or landowner gauging interest from the other. A developer will perform their due diligence by thoroughly evaluating the ...

Farmers and landowners can register their property for lease on an internet portal that has been set up. The Rajasthan government has started a program to assist farmers who want to build solar energy plants on their unusable or unused property (Barren Land).

Solar developers pay anywhere from a few hundred dollars up to a few thousand dollars per acre leased. It varies considerably by the developer, the size of the project, the state the land is in, market competition in the area (from other solar developers as well as companies interested in your land for other uses), and several other factors.

(i) As buying agricultural land in Rajasthan is cumbersome, solar developers in recent months prefer taking project lands on a long lease basis. Leasing of land (in lieu of outright acquisition) has two salient advantages: a.

The solar lease negotiation process is the first step landowners take when interested in having a solar farm on their property. (i) The Indian state of Rajasthan - with abundantly available land, sunlight and an enabling policy framework, is a preferred destination for project developers in the solar power sector. Ostensibly, Rajasthan's Solar Policy 2019 ("SolarPolicy") exempts project developers from the regulatory rigours of acquiring agricultural land.
