After Solyndra went bankrupt in August of 2011, the U.S. department of Energy approved a deal to attract more private investment to the company. Part of the deal was that the private creditors could write-off more than \$350 million in taxes, making the total loss to American taxpayers for Solyndra as much as \$849 million.
