Cost of Solar Panels in Texas After Tax Credit and Discounts. Raw Cost of 5kW producing solar panels = \$13,800-22% in Federal Tax Credits = $\$13,800 * .78 = \$10,764$ (\$3,036 in tax credits)-\$2,000 conservative estimate of power company rebate = $\$10,764 - \$2000 = \$8,764$
