This saves solar users more money than the pre-2019 system, under which ...

During the summer's hearings for Georgia Power's long-term plans, Echols failed to get the support needed to open the solar program to 75,000 customers. He said that he was willing to compromise on this proposal while asking solar experts Thursday if they can quantify how all customers might benefit from the solar rooftop households.

Georgia Power has consistently signaled it prefers utility scale solar energy production, as in this solar farm in Bibb County, over dispersed rooftop solar installations. A program that helped make rooftop solar affordable for the utility's customers reached its 5,000-customer cap in summer 2021, making solar power more expensive for the end ...

Unlike many states that give residents money or tax credits to offset the cost of solar, Georgia does not have any statewide incentive programs of this type. It's best to look to programs run by local communities or utility companies for financial help.

Georgia Power continues to grow renewable energy through its new Customer-Connected Solar Program (CCSP), a 25-MW Distributed Generation customer-sited program. Working with the Georgia Public Service Commission on the program design, the Commissioners gave their approval in May 2020.

But as of early February, a 10-kilowatt solar array crowns the Morgan home. Two large backup batteries are coming soon. Savannah-based Be Smart Home Solutions is installing the system as part of the Georgia Bright program, which leases rooftop solar to Georgia homeowners with a household income less than \$100,000.

Through continued development of CCSP, as well as other solar projects and programs, Georgia Power expects to add up to 1,400 MW* of additional renewable capacity by the end of 2021.

By allowing individuals to buy solar equipment in bulk, programs in Atlanta and Savannah aim to help make renewable energy affordable. ... But for Georgia Power customers, it's not quite that simple. Most still need to get some of their electricity from the utility, and a program that made that mix of power sources affordable has just filled ...

The Georgia Solar Power Program. In Georgia specifically, using solar energy is possible. However, because it isn"t quite as common in the state, fewer local incentives exist to make the switch. Georgia does not offer statewide incentives or tax credits for those who install solar panels on their homes. But there is a federal tax credit.

Georgia solar panels typically cost about \$37,400 for a 10 kilowatt system. Residents can significantly reduce their energy bills and save thousands by investing in home solar panels. The federal solar tax credit can help you recover 30% of the cost of your solar panels. Currently, there are no free solar panel programs in Georgia.
